## Paddle UK – Sudbury Canoe Club – Come and try it on Friars Meadow Risk Assessment

Notes	This is an event involving members of the public who are not club members. A higher degree of supervision and care is therefore necessary since many of the participants will be new to paddlesports. This RA assumes that before the event, a lead coach/instructor (the "Lead") is designated to organise and supervise the event.  If a barbecue is run, an individual needs to be designated as the barbecue supervisor. A further person needs to be designated as the "check in" individual. A further person needs to be designated as the "bank supervisor" individual. These three roles may be shared between several people during the day so long as at all times there is someone responsible for each.  In addition there will need to be enough "SCC helpers" to supervise participants on the water – these will either be qualified Paddle UK Coaches/instructors or others assessed by the Lead as suitably experienced to supervise and deal with any emergency that may arise

Drowning	All	Properly fitting Buoyancy aids to be worn at all times on the water.  Participants on the water to be supervised by SCC helpers. SCC helpers will either be qualified Paddle UK Coaches/instructors or others assessed by the Lead as suitably experienced to supervise and deal with any emergency that may arise.
